

Contract / Terms and Conditions

This contract is made between LaVere Media (Rich and Connie LaVere), the provider of photographic and/or video services, and the PURCHASER of said services. Authorized signatures of the PURCHASER as well as LaVere Media deem that the following conditions are hereby agreed to:

1. LaVere Media agrees to provide photo and/or video production services as outlined below:

Package One: Standard includes all-day coverage of your preparation before the wedding, the wedding, and the wedding reception. LaVere Media will provide 4x6 photos of all pictures taken during the day. Additional copies and enlargements will available at standard pricing through a secure website.

Total Price \$1,600 — \$400.00 deposit at contract signing; \$400 on day of wedding and balance due immediately upon receipt of photos*

Package Two: "Basic Plus" includes all-day coverage of your preparation before the wedding, the wedding, and the wedding reception. LaVere Media will provide one set of 4x6 photos of all pictures taken during the day, and an additional 300 photos chosen by the customer. 24 enlargements (5x7 or 8x10) will be provided in a "portrait book". All "digital negatives" and any film negatives will be provided, as well as a signed "copyright release" form from LaVere Media. A DVD with all your photos, set to music, will also be provided. Additional copies and enlargements will available through a secure website.

Total Price \$2,000 — \$700.00 deposit at contract signing; \$700 on day of wedding and balance due immediately upon receipt of photos*

Package Three: "Deluxe" includes a pre-wedding portrait shoot at the LaVere Media studios, with up to four hours of photography of the bride, groom, and anyone else chosen by the PURCHASER. LaVere Media will provide 10 8x10 prints of your choice from this photo session. LaVere Media will provide all-day coverage of your preparation before the wedding, the wedding, and the wedding reception. LaVere Media will provide one set of 4x6 photos of all pictures taken during the day, and an additional 300 photos chosen by the customer. Two "portrait books" with up to 24 enlargements (5x7 or 8x10) will be provided. All "digital negatives" and any film negatives will be provided, as well as a signed "copyright release" form from LaVere Media. Additional copies and enlargements will available through a secure website.

Total Price \$2,750 — \$950.00 deposit at contract signing; \$900 on day of wedding and balance due immediately upon receipt of photos*

** NY State sales tax will be added to all purchases, including deposit. All videos in every package include music (where appropriate), titles, and special dust-free packaging of your DVD or videotape for long-term storage. Mileage will be charged at a rate of .35/mile after the first 25 miles traveled, per total mileage traveled for the day.*

Video coverage is available with any package for an additional \$400. Video coverage consists of a single (unattended) camera at the ceremony, with a remote groom-mounted microphone. Video coverage of the reception will include introductions, toasts and first dances (i.e., Bridal, Bridal Party, Mother/Son, Father/Daughter and any other "special" dances as required). Video charges must be pre-paid at contract signing.

2. LaVere Media shall be provided access to the wedding site 60 minutes prior to ceremony.

- 3. Video (if applicable) will be taped under existing lighting conditions unless other arrangements are specifically made and agreed to by all parties involved.
- 4. Meals will be provided for representatives of LaVere Media at the wedding reception.
- 5. LaVere Media will honor any reasonable special requests within the limits of the package purchased, providing PURCHASER notifies LaVere Media upon signing this contract.
- 6. The PURCHASER agrees to compensate LaVere Media for the full balance due in cash or check immediately upon receipt of photos and/or video.
- 7. Cancellation of video services by the PURCHASER is strictly prohibited. Upon such a cancellation, the PURCHASER hereby agrees to forfeit any deposit. Cancellation within 60 days prior to date specified below will result in payment due on the balance of the full amount due.
- 8. (If applicable): DVDs are duplicated on high-quality DVD-R discs that will play back on most home systems. In the event that the DVD will not work with your particular player, LaVere Media will substitute a VHS tape at no cost.
- 9. LaVere Media shall retain the copyright for the edited photos and/or video, and maintains the right to use the photos and/or footage for promotional or other purposes in perpetuity.
- 10. LaVere Media and the PURCHASER also agree to the following specifics:
